1. MONOCLONAL ANTIBODY TREATMENT: Great news! Today we opened a MAB clinic on Sabattus Street, in the building also used by Maine Urgent Care – Lewiston. These treatments are by appointment only with a physician order. We are sharing this information with the medical staff and the primary and specialty care practices. There is no walk-in availability and the MAB clinic is not part of Maine Urgent Care.

We are also working on a state application for a one-stop shop that would test, administer and complete prescriptions. We hope to be able to make oral therapies available to our patients through our retail pharmacy.

- **2. MAINE NATIONAL GUARD:** The Guard's time with us is winding down. Thirty-two Guard members will be leaving at the end of the month. Please be sure to thank them for all their help.
- **3. TALENT POOL:** This resource to help short-staffed departments will be even more important given the upcoming departure of Guard members.
